# **Detailed biography**

### Pre War

Albert Edwin (Ted) GARDINER worked as a junior clerk at Western Australian Government Railways prior to enlistment.

### War Service

Enlisted on 3 July 1943 at No. 4 RAAF Recruiting Centre [https://www.birtwistlewiki.com.au/wiki/No.\_4\_RAAF\_Recruiting\_Centre], Perth, on 3 July 1943. He was classified Aircrew V, under training.\*

Re-mustered as Aircrew V (Gunner) on 7 September 1943.

Promoted to Leading Aircrewman, under training, on 11 September 1943.

Posted to No. 1 Wireless Air Gunners School RAAF[https://www.1wags.org.au/], Course 42 and Course 43 at Ballarat from 16 September 1943 to 9 February 1944.

On 31 December 1943 he received a trade classification as Aircrew V (Gunner).

Re-mustered as Air Gunner, promoted to Sergeant, under training, and received the Air Gunner's badge on 30 March 1944.

Court-martialed on 21 March 1945.

At the court-martial he was charged with three offences.

The first charge under section 5.5(8) of the Air Force Act was for 'Failing to use his utmost exertions to carry such orders into effect'. It was alleged that 'he at Royal Air Force Station, Waddington, on the night of 19/20th February, 1945, when under orders to carry out a warlike operation in the air, namely to act as air gunner in His Majesty's aircraft Lancaster PD.330, on an operational flight for the purpose of bombing BOHLEN through default failed to use his utmost exertions to carry such orders into effect by failing to present himself at the said aircraft in sufficient time for take off for such flight.'

The second charge, as an alternative to the first charge, under section 15(1) of the Air Force Act was for 'absenting himself without leave'. It was alleged that 'he at Royal Air Force Station, Waddington on the night of the 19/20th February, 1945, failed to report for duty at 22.42 hours as air gunner in His Majesty's aircraft Lancaster PD.330 as it was his duty to do and remained absent without leave until approximately 23.00 hours on the same night.'

The third charge, under section 8(2) of the Air Force Act was for 'Using insubordinate language to his superior officer'. It was alleged that 'he at Royal Air Force Station, Waddington, on the night of the 19/20th February, 1945, when ordered by Squadron Leader D.J. SULLIVAN, DFC. NO.463 Squadron, to fly with his crew on operations that night replied to the said Squadron Leader SULLIVAN "I refuse to fly" or words to that effect.'

He was found guilty of the first and third charges, and reduced to ranks. He was re-mustered to the rank of Leading Aircrewman (General Hand) and relinquished his Air Gunner's badge.

He was sentenced to 18 months detention, with 12 months of the sentence remitted by Air Vice Marshal HA Constantine, Air Officer Commanding, Headquarters, No. 5 Group RAF [https://en.wikipedia.org/wiki/No.\_5\_Group\_RAF], on 10 April 1945, and forfeited 30 days pay. Subsequently he received a further remission of 61 days under the 'Rules for Detention Barracks and Voluntary Prisons'.

At No. 53 Base RAF[https://www.rafweb.org/Organsation/Bases.htm] he was released from the detention barracks at Sowerby Bridge on 21 July 1945.
